## TOWPATH TRAIL EXTENSION PROJECT

The Towpath Trail & Greenway is identified in the following regional, county, watershed and community level plans and is consistent with their strategies and priorities.

## State Plans:

- Statewide Comprehensive Outdoor Recreation Plan for Ohio (SCORP, 2013). The Report identifies the
  Towpath Trail (page 23) and asserts that former towpaths, like the trail running through the property,
  provide numerous opportunities for recreational users (page 42). This project addresses the ODNR, Division
  of State Parks's priorities and strategies including land acquisition and conservation to protect Ohio's
  natural, native landscapes.
